ARTICLES OF ORGANIZATION OF SNAPP2-IT-CONSTRUCTION SERVICES, LLC

The undersigned, for the purpose of forming a limited liability company under the Exorida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be SNAPP2-IT-CONSTRUCTION SERVICES, LLC ("Company").
