
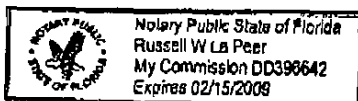

Article VII – Member Liability



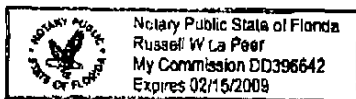
