## ARTICLES OF ORGANIZATION OF ROTHSCHILD INVESTMENTS, LLC

### ARTICLE I

#### Name

The Company will be managed by a manager or managers and is accordingly a manager-managed company. The name and address of the initial Co-Managers of the Company is:


