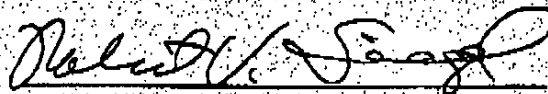

Management**

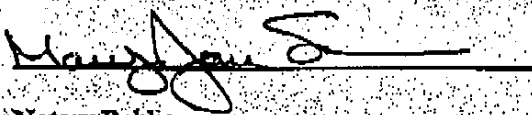
