ARTICLES OF ORGANIZATION OF WESLEY, McGRAIL & WESLEY, P.I.L.C.

The undersigned, pursuant to the provisions of Chapter 621 of the Florida Statutes, for the purpose of forming a professional limited liability company under the laws of the State of Florida, set forth the following:

ARTICLE I - NAME

The name of this professional limited liability company is WESLEY, McGRAIL & WESLEY, P.J.J.C. (the "Company").

ARTICLE II - PERIOD OF DURATION

Unless otherwise terminated pursuant to applicable law or as provided in the Company's operating agreement, the Company shall have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

The nature of the business to be transacted by the Company shall be to engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by attorneys licensed under the state of Florida. Furthermore, no member of the Company shall enter into any agreement vesting another person with the authority to exercise any of that member's voting power in the Company.
