**ARTICLES OF ORGANIZATION
OF
WESLEY, McGRAIL & WESLEY, P.L.L.C.**

The undersigned, pursuant to the provisions of Chapter 621 of the Florida Statutes, for the purpose of forming a professional limited liability company under the laws of the State of Florida, set forth the following:

ARTICLE I - NAME

The name of this professional limited liability company is **WESLEY, McGRAIL & WESLEY, P.L.L.C.** (the "Company").

ARTICLE II - PERIOD OF DURATION

Unless otherwise terminated pursuant to applicable law or as provided in the Company's operating agreement, the Company shall have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

The nature of the business to be transacted by the Company shall be to engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by attorneys licensed under the state of Florida. The professional services rendered by the Company may be rendered only through individuals duly licensed to render such legal services under the laws of the State of Florida. The Company shall not engage in any business other than the rendition of legal services, however, the Company may invest its funds in real estate, mortgages, stocks, bonds or any other type of

investment and may own or lease real and personal property necessary for the rendering of professional legal services.

No person shall be admitted as a member of the Company, unless such person is a professional corporation, a professional limited liability company, or an individual, each of which is duly licensed to render professional legal services. Furthermore, no member of the Company shall enter into any agreement vesting another person with the authority to exercise any of that member's voting power in the Company.

**ARTICLE IV - MAILING AND STREET ADDRESS
OF THE PRINCIPAL OFFICE OF COMPANY**

The mailing and street address of the principal office of the Company is 88 Eglin Parkway, Fort Walton Beach, Florida 32548.

ARTICLE V - INITIAL REGISTERED AGENT

The name and street address of the initial registered agent in Florida for the Company is JOHN W. WESLEY whose address is 88 Eglin Parkway, Fort Walton Beach, Florida 32548.

ARTICLE VI - ADDITIONAL MEMBERS

An interest of a Member of the Company may only be transferred or assigned to such extent as is provided in the Company's operating agreement and in accordance with Chapter 621 of the Florida Statutes.

ARTICLE VII- MANAGEMENT

The Company is to be managed by its members, and is therefore a member-managed professional limited liability company. The name of the initial members of the Company are:

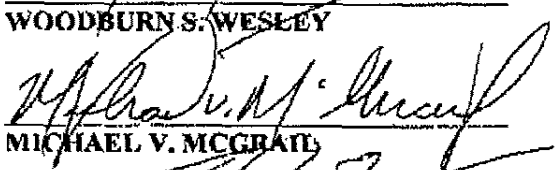
