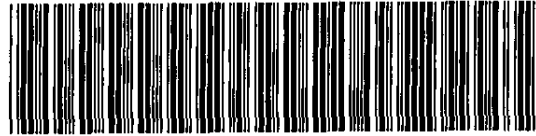

**ARTICLES OF ORGANIZATION**  
**OF**

**ARTICLE I.**  
**Name**

The name of the Professional Limited Liability Company shall be The Law Offices of Charles W. McKinnon, P.L.

**ARTICLE II.**  
**Duration**

This Professional Limited Liability Company shall exist perpetually, unless dissolved according to law or as set forth in this Professional Limited Liability Company's Operating Agreement.

**ARTICLE III.**  
**Purpose and Powers**

Except as restricted by these Articles of Organization, this Professional Limited Liability Company is organized for each and every legal and lawful purpose for which a Professional Limited Liability Company may be organized pursuant to the Florida Professional Service Corporation and Limited Liability Company Act.

**ARTICLE IV.**  
**Principle Office**

**ARTICLE V.  
Registered Agent**

**ARTICLE VI.  
Admission of Additional Members**

Additional members may be admitted to this Professional Limited Liability Company upon the unanimous consent of all members in writing and then only upon the condition that a new member be bound by and become party to the Operating Agreement of this Professional Limited Liability Company.

**ARTICLE VII.  
Dissolution, Continuation**

Additional Provisions**

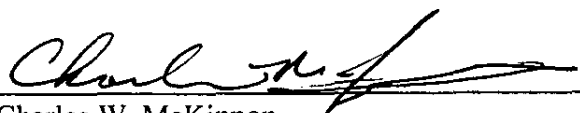
