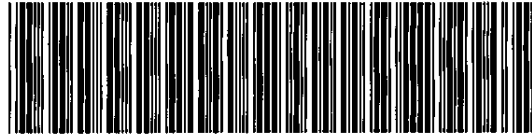

The name of the limited liability company shall be **BC-MIGNA GROUP LLC**, ("Company").

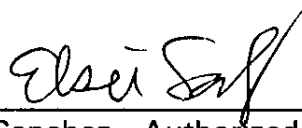
