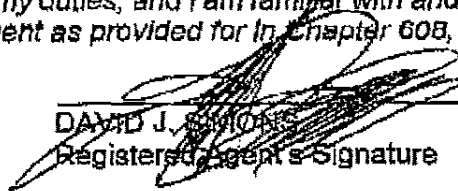

ARTICLE V - Effective Date

The Limited Liability Company shall have an effective date of July 10, 2006.

ARTICLE VI - General Nature

The general nature of the business and objects and purposes proposed to be transacted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as natural persons might or could do, to wit:

A. To buy, sell, rent and lease real estate for the use of the corporation or to lease or rent to other entities.

B. To buy, sell, rent and lease automobiles, vans, trailers, boats, trucks or other vehicles for the use of the corporation.

C. To buy, sell, rent, lease or operate any other items to the general public.

D. It is the intention that each of the objects, purposes and powers specified in each of the paragraphs of this Articles of Incorporation shall, except where otherwise so specified, be nowise limited or restricted by reference to or interference from the terms of any other paragraph or of any other Article in these Articles of Incorporation, but that the objects, purposes and powers specified in the article, and in each of the article or paragraphs of these articles, shall be regarded as independent objects, purposes and powers of this corporation, nor shall the expression of one thing be deemed to exclude another, although it be of a life nature. The enumeration of objects or purposes herein shall not be deemed to exclude or in any way limit by inference, any powers, objects or purposes which this corporation is empowered to exercise, whether expressly by force of these laws of the State of Florida, now or hereafter in effect or implied by any reasonable constructions of said law.

ARTICLE VII

This Limited Liability Company shall have a thirty (30) year existence from the date of organization unless dissolved according to law. The owners should have the right to renew the existence of the corporation upon mutual consent for an additional thirty (30) years at the expiration of any thirty (30) year period.
