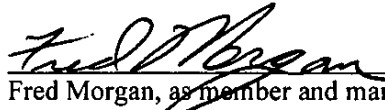
WHEREAS, the undersigned, being all of the members of the Company, now desire to amend the Articles so as to change the name of the Company; and

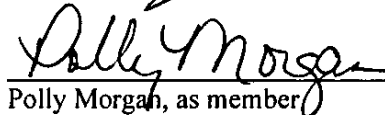
NOW THEREFORE, the undersigned, being all of the members of the Company, do hereby adopt the following amendment to the Company's Articles of Organization:

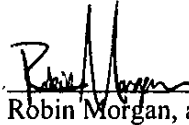
1. Name. The name of the Company is FRP, LLC.
