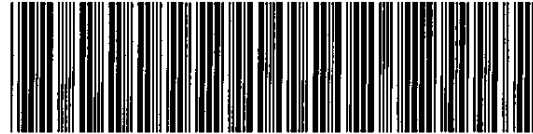

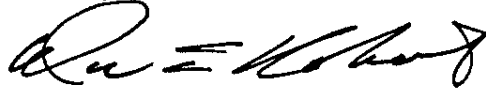

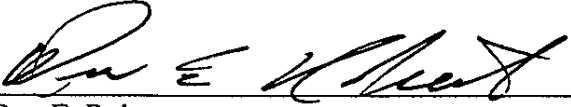
A LIMITED LIABILITY COMPANY

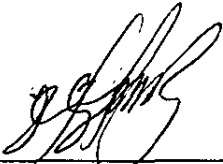
