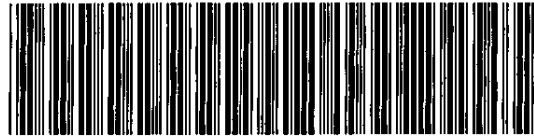

**ARTICLE I - NAME**

The name of the limited liability company shall be Aker Marketing & Design, LLC ("Company").

**ARTICLE II - PURPOSE AND POWER**

The purpose for which the Company is organized is to own and operate a marketing and design company and to otherwise engage in any lawful act, activity or business permitted under the laws of the United States and the State of Florida.


