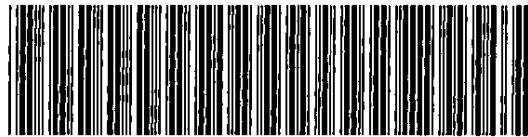


MEMBERSHIP
