# ARTICLES OF ORGANIZATION OF PLEASURE SEEKERS REAL ESTATE INVESTMENTS, LLC

#### ARTICLE I – NAME

- 1.1 The name of this entity is PLEASURE SEEKERS REAL ESTATE INVESTMENTS, LLC

#### **ARTICLE II - DURATION**

8.1 <u>Death, Resignation, Etc. of a Member.</u> If a Member dies, resigns, becomes bankrupt, dissolves, or if the existence of a Member that is a corporation or other legal entity terminates (the "Incapacitated Member"), or other act of dissolution occurs under Section 608.441(1), <u>Florida Statutes</u>, the Company shall be dissolved six (6) months after the event unless: (a) The Company is continued by the consent of a majority in interest (as such term is interpreted for purposes of Section 301.7701-2(b)(1) (H060001772633)

of the Treasury Regulations) of the remaining Members; and (b) Either there are at least two remaining Members, or a new member is admitted to the Company. If the business of the Company is continued, a Majority in Interest of the remaining Members shall elect either to: (i) permit the Incapacitated Member's successor-in-interest to continue as an Assignee or substitute Member, or (ii) cause the Limited Liability Company to redeem the interest of the Incapacitated Member on the terms set forth in the Regulations. The Section is intended to expand the ability of the Limited Liability
