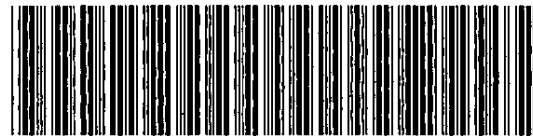

Advanced Technology Solutions MLC LLC (ATS) wishes to dissolve their partnership effective July 31, 2008. Mr. Kevin Calderbank has abandoned his position as a partner and cannot be located after several attempts to contact him via registered mail, e-mail, and phone. He has refused any correspondence from Natalie Little and Alexandra Mores since March 15, 2007. On March 15, 2007 he met with Alexandra Mores to sign papers related to a settled lawsuit against Advanced Technology Solutions MLC LLC and after this meeting took place he has not responded to any correspondences, nor made any attempt to contact either of the partners. The only correspondence Kevin Calderbank has responded to was a letter from our attorney dated May 25, 2007 requesting the return of a laptop and any other materials belonging to ATS. Mr. Calderbank did return the laptop and materials to an assistant in our attorney's office around June 1, 2007 and left prior to signing the dissolutions form. Since then, Mr. Kevin Calderbank has made no effort to contact nor has he responded to any written or oral communications from either Natalie Little or Alexandra Mores and therefore we consider him a rogue partner and wish to dissolve the partnership effective July 31, 2008. The company has done no business since June of 2007. At this time all debts, obligations and liabilities of the limited company have been paid or discharged.
