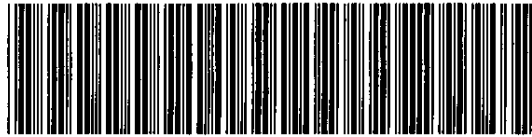



RCA I, LLC


ARTICLE II – Address
