ARTICLES OF ORGANIZATION OF TALLAHASSEE, ELONG

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I NAME AND ADDRESS

The name of the limited liability company shall be Gref Investments, LLC ("Company").
