**ARTICLES OF ORGANIZATION
OF
MOISAN ENTERPRISES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **Moisan Enterprises, LLC** ("Company").

ARTICLE V - TERMINATION OF EXISTENCE


The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.
