ARTICLES OF ORGANIZATION

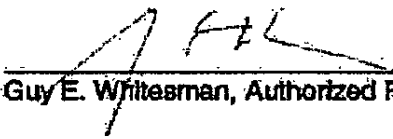
ARTICLE IX-OPERATING AGREEMENT
