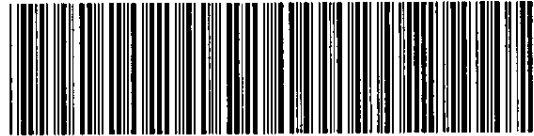


ARTICLE VI
