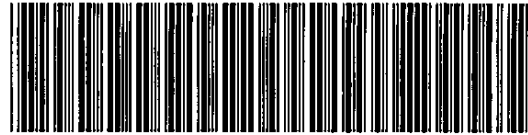

SMITH TWINING, LLC**

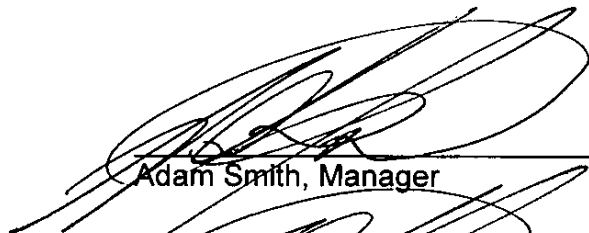

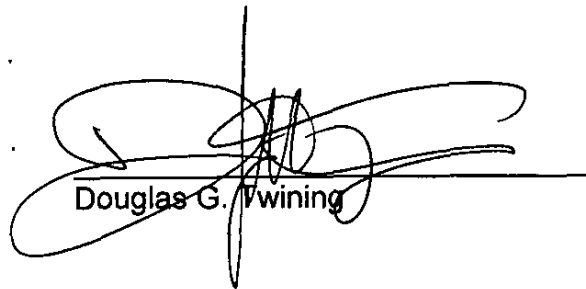
