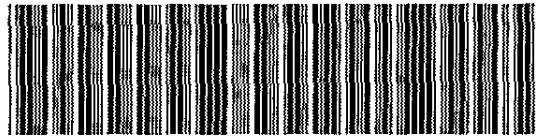

NAME
