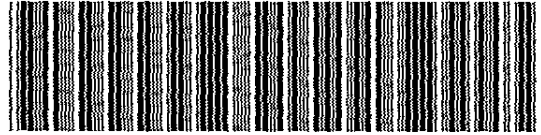

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (the "Act"), the limited liability company named below is hereby formed by the undersigned individual, acting as the sole organizer thereof, by the adoption and filing of these Articles of Organization providing as follows:

1. **Name.** The name of the limited liability company is J.D. RYNARD CONSTRUCTION OF FLORIDA, LLC (the "**Company**").

2. **Address.** The street and mailing address of the principal office of the Company is 43 River Drive, Tequesta, Florida 33469.

3. **Registered Office, Registered Agent and Registered Agent's Signature.** The street address of the Company's registered office in Florida is 43 River Drive, Tequesta, Florida 33469, and the name of the Company's registered agent at that office is John D. Rynard.

Having been named as registered agent and to accept service of process for the Company at the place designated in these Articles of Organization, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in the Act.
