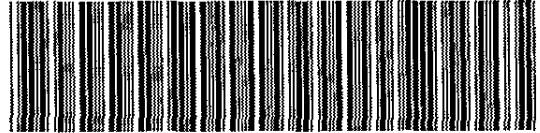

**ARTICLES OF ORGANIZATION
PEACE RIVER EXCAVATING, L. L.C.**

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
Name**

The name of the limited liability company, referred to in these Articles as "Company" is Peace River Excavating, L. L. C.

Duration**

The company shall dissolve on December 31, 2036.

ARTICLE VIII Admission of New Members

Members shall have the right to admit new members. Additional members may be admitted only on the unanimous written consent of existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. Provided, however, the original member may transfer all or part of his interest to an immediate member of his family and these family members shall automatically be admitted as members.

ARTICLE IX Remaining Members

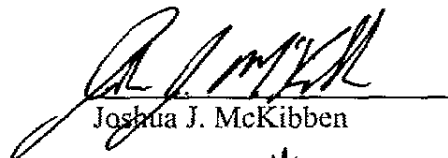
