

2. **Description of occurrence that resulted n the limited liability company's dissolution pursuant to § 608.441, Fla. Stat.:**

Written Consent of All Members. The undersigned, constituting the sole member and manager of SICAR, LLC, hereby voluntarily dissolves SICAR, LLC pursuant to Article 13.1(d) of the Operating Agreement.
