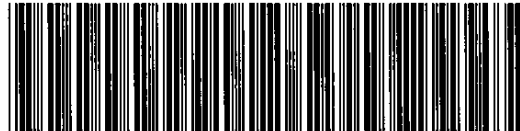

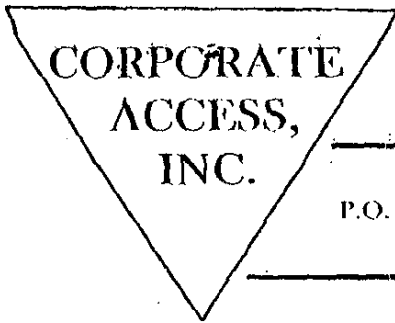



##### MEMBERS RIGHTS TO CONTINUE BUSINESS


