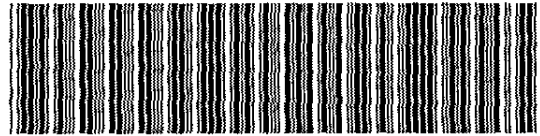

**ARTICLES OF ORGANIZATION
OF
WILLIAMS APPRAISING, LLC**

The undersigned, for the purpose of forming a Professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **WILLIAMS APPRAISING, LLC**, ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be **WILLIAMS APPRAISING, LLC**, 206 Live Oak, New Smyrna Beach, Florida 32168, and the mailing address is the same.

ARTICLE III -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT
