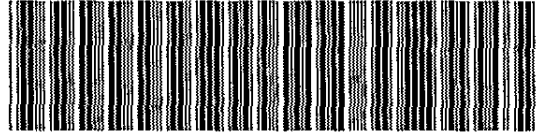

**ARTICLES OF ORGANIZATION
OF
WILLIAMS PROPERTIES, LLC**

The undersigned, for the purpose of forming a Professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **WILLIAMS PROPERTIES, LLC**, ("Company").

ARTICLE II -- ADDRESS

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

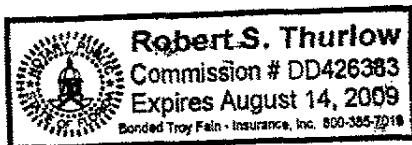
