

# ARTICLES OF ORGANIZATION OF WILLIAMS REAL ESTATE, LLC

The undersigned, for the purpose of forming a Professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME
