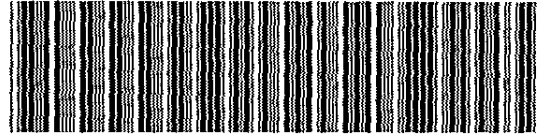

**ARTICLES OF ORGANIZATION  
OF  
WILLIAMS REAL ESTATE, LLC**

The undersigned, for the purpose of forming a Professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **WILLIAMS REAL ESTATE, LLC**, ("Company").

**ARTICLE II -- ADDRESS**

The street address of the principal office of the company shall be **WILLIAMS REAL ESTATE, LLC**, 206 Live Oak, New Smyrna Beach, Florida 32168, and the mailing address is the same.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

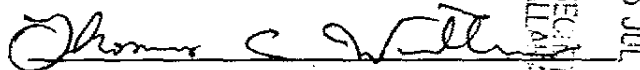

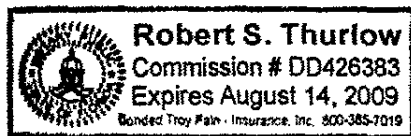
