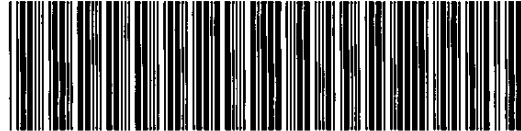

ARTICLE I - NAME

The name of the limited liability company shall be TOM & DAWN VENTURES, LLC ("company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. ARTICLE VI - MANAGEMENT

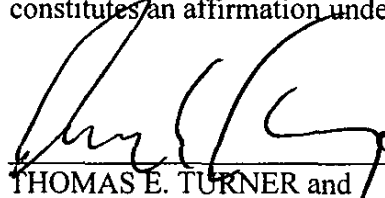

ARTICLE VII – LIMITATION ON AGENCY AUTHORITY OF MEMBERS

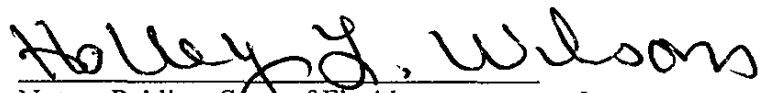
Pursuant to Section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.

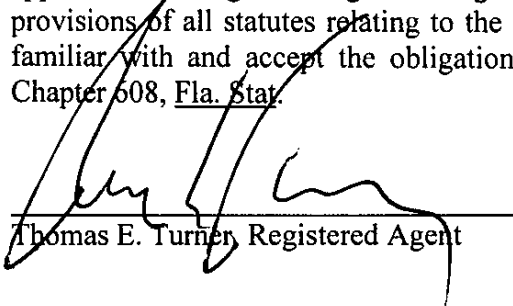
