**ARTICLES OF ORGANIZATION  
OF  
OLD CORKSCREW ENTERPRISES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be OLD CORKSCREW ENTERPRISES, LLC (the "Company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the initial principal office of the Company shall be 26811 South Bay Drive, Suite 240, Bonita Springs, FL 34134.

**ARTICLE III -- DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the operating agreement adopted by the Members for the management of the business and affairs of the Company (the "Operating Agreement").

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

**ARTICLE V -- TERMINATION OF EXISTENCE**

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.

**ARTICLE VI -- MANAGEMENT**

The Company shall be a manager-managed company and shall be managed by at least one Manager who may, but need not, be a Member, in accordance with the Operating Agreement. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. At the time that these Articles of Organization are executed, the Manager of the Company is CORKSCREW PLANTATION, INC., a Florida corporation
