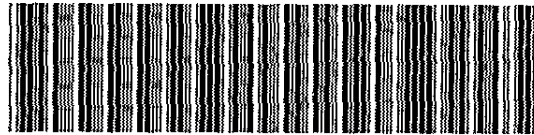

Additional members may be admitted upon approval of all of the Members of the Company.


