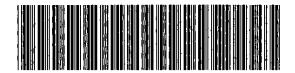

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF TIMBER LAND RESOURCES, LLC

Article 8 is hereby deleted in its entirety and replaced with the following:

8. CONTINUITY OF BUSINESS.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member of the Company, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of the remaining Members of the Company owning a majority of the ownership interests in the Company.

Article 9 is hereby deleted in its entirety and replaced with the following:

MANAGEMENT.

The Company shall be manager-managed. The sole Manager of the Company is BFLP I, LLC, 320 U.S. Highway 41 South, Inverness, FL 34450.

Article 10 is hereby deleted in its entirety and replaced with the following:

10. INDEMNIFICATION.

Unless expressly agreed otherwise in writing by the Members owning a majority of the ownership interests in the Company, the Company shall indemnify all Members Managers, former Members and former Managers to the full extent permitted under the Florida Limited Liability Company Act.
