**ARTICLES OF ORGANIZATION

Article 1. Name. The name of the Limited Liability Company is TRACY FAMILY-NAPLES, LLC

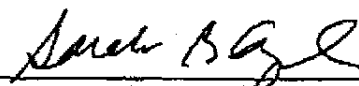
