The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

#### **ARTICLE I**

**ARTICLE IV**

**REGISTERED OFFICE AND AGENT**

The initial street address in Florida of the initial registered office of the Company is 1675 Rachel's Ridge Loop, Ocoee, Florida 34761, and the name of the initial registered agent at such address is **JAYESH A. PATEL**.

**ARTICLE V**

**CAPITAL CONTRIBUTIONS**

Company holding membership units of ten percent (10%) or greater, other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

### **ARTICLE VIII**

#### **MEMBERS' RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by majority consent of all the members of the Company holding membership units of ten percent (10%) or greater.

### **ARTICLE IX**

#### **MANAGEMENT**

The Company shall be managed by the managing member in accordance with Regulations adopted by the members for the management of the business and affairs of the Company. These Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
