ARTICLES OF ORGANIZATION OF

These Articles of Organization of COIN DEVELOPMENT III, LLC, have been duly executed and are being filed by the undersigned authorized representative of a member to form a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608) as follows:

**ARTICLE I
NAME AND ADDRESS**
