ARTICLE VII - MANAGEMENT

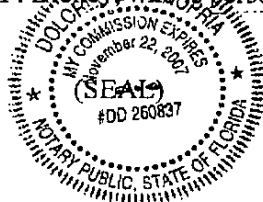
