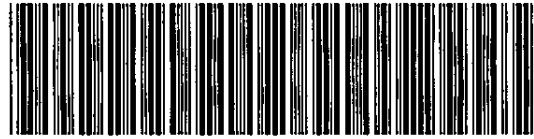


**THE AMENDMENTS**
