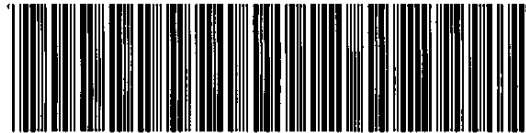

MANAGEMENT


The management of the Company is reserved to the members of the Company in accordance with the Company's operating agreement.
