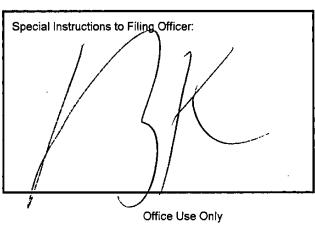

ARTICLES OF ORGANIZATION FOR OCEAN DRIVE REALTY COMPANY LLC

A Florida Limited Liability Company
