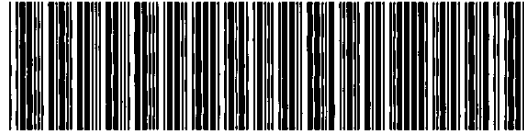

ARTICLES OF ORGANIZATION OF IWIN STORE, LLC

The undersigned, FRANK MAGGIO, as the subscriber to these Articles of Organization, hereby present these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

ARTICLE I. NAME OF LIMITED LIABILITY COMPANY

The initial registered agent of the limited liability company shall be the following named person at the following address:



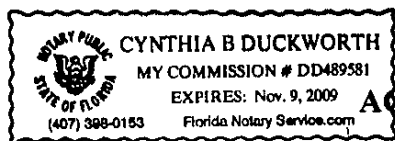
