Registered Agent and Office

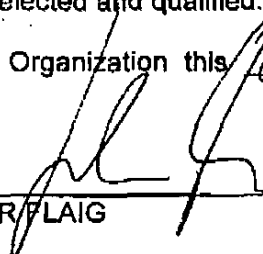
