

The undersigned, for the purpose of forming a limited liability company under the Florida DA Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I NAME


### ARTICLE IV REGISTERED OFFICE AND AGENT
