**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I - NAME**

**ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE**

**ARTICLE III - PURPOSE**

ARTICLE X - TERMINATION OF MEMBERSHIP INTEREST


