

ARTICLES OF AMENDMENT OF

Pursuant to §608.411 of the Florida Statutes, Bella Dente Fine Dentistry, LLC., a Florida Limited Liability Company, organized and existing under the laws of the State of Florida, adopts the following Articles of Amendment to its Articles of Organization:

1. Article I of the Articles of Organization is hereby deleted and replaced with the following:

ARTICLE I

The name of the Professional Limited Liability Company shall be BELLA DENTE FINE DENTISTRY, P.L., a Florida Professional Limited Liability Company.

2. Article III of the Articles of Organization is hereby deleted and replaced with the following:

ARTICLE III
