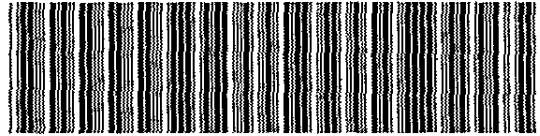

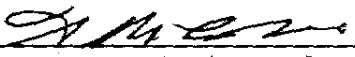
ARTICLE III. PURPOSE
