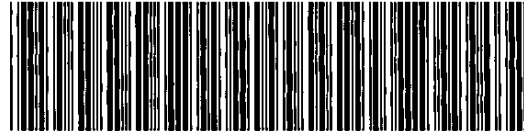

**Article IV. Management**

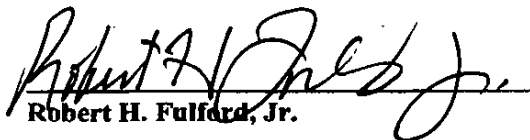
The Company shall be managed by the members.
