

ARTICLES OF ORGANIZATION

OF

- The undersigned person, seeking to form a limited liability company under the Florid Statutes, Chapter 608, hereby executes the following Articles of Organization.
- I NAME. The name of the limited liability company shall be: Surgery Center Building Partnership, L.C. ("Company").
