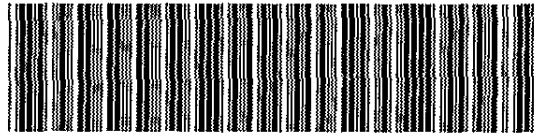

ARTICLES OF ORGANIZATION
OF
FORTE REAL ESTATE MANAGEMENT AND CONSULTING, LLC

The undersigned, being a duly authorized Member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I
NAME

The name of the limited liability company (the "Company") shall be **FORTE REAL ESTATE MANAGEMENT AND CONSULTING, LLC**.

ARTICLE II
PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be **625 N. North Court, Suite 100, Palatine, IL 60067**.

ARTICLE III
REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered agent of the Company is at **124 S. Florida Avenue, Suite 203, Lakeland, FL 33801**, and the name of the initial registered agent at such address is **Harold J. Webre, P.A.**

ARTICLE IV
EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

ARTICLE V
DURATION

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members, if any, shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

ARTICLE VI
ADOPTION OF OPERATING AGREEMENT AND REGULATIONS

The initial Operating Agreement and Regulations of the Company shall be adopted by its initial Members. The Operating Agreement and Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

ARTICLE VII
INITIAL MANAGERS

The Company will be managed by one or more Managers, who shall be designated, appointed or elected as more fully described in the Operating Agreement and Regulations. The initial number of Managers of the Company shall be three (3). The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
